Production (pasteurization, churning) of butter, milk fat spread packed in aluminum laminates, pouch and HDPE bags; (lactic fermentation) sour cream, curdled milk, and cottage cheese (curd grains treatment) packed in PP containers with aluminum lids; buttermilk and kefirs packed in laminate cartons.
